#### MEMORANDUM OF UNDERSTANDING

The Lokopriya Gopinath Bordoloi Regional Institute of Mental Health, (Hereafter referred to as LGBRIMH) Tezpur, Assam, provides patient care services in the field of Mental Health, development of manpower in Psychiatry, Psychiatric Social Work, Clinical Psychology and Psychiatric Nursing and other allied health care courses. The Institute extends community services under District Mental Health Programme / National Mental Health Programme and provides specialized training to UG (Nursing) and PG students, trainees and research workers and specially for youth (Youth wellness Hub) on the areas i.e. need of mental health support towards students. Hereafter called the first party and for brevity as LGBRIMH.

hereinafter called the second party. NOW THEREOF AND THE LGBRIMH have intended, agreed and consented to the following terms and deeds for research and training of students/faculty in LGBRIMH.

1.1 Institute may get their personnel trained in the subjects of mutual interest in their organizations, and also encourage their scientists/faculty/students of either institute to attend lectures, workshop and conferences conducted in their respective area of interest.

1.2 LGBRIMH, having the professional skills and qualified and experienced trained human resources, will take responsibility for imparting necessary and appropriate technical assistance in terms of teaching, research and training etc. Both the parties may conduct joint research and extension activities under collaborative arrangements.

1.3 The students may be placed for short term and definite period of training / exposure posting. The exposure training will be given as per convenience and current posting schedule of LGBRIMH.

1.4 The posted students will maintain Institute's decorum and will abide by and comply with the academic rules and regulations of LGBRIMH.

1.5 LGBRIMH will not provide accommodation to trainees.

1.6 Trainees will not be allowed to take any photographs of patients either from indoor or outdoor. Any breach will be regarded as gross misconduct and this may even lead to expulsion of the delinquent student.

1.7 Research activities, community activities may be carried on mutually to achieve a meaningful and purposeful result.

Both the parties shall evolve a mutually acceptable and convenient schedule for training.

The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the parties of MOU.

The parties to this memorandum may, by mutual consent, add, modify, amend, delete, review or revise any term(s) and condition(s) of this agreement during subsistence of this MOU.

The intent and implementation of this memorandum is SUBJECT to the policies of the GOVT. of India and laws of the land. The MOU shall

remain in force for a period of 5 (five) years from the date of its signature and seal, and may be terminated by either side by giving a month's notice to that effect in writing. However, notwithstanding the notice of the intent to terminate the memorandum, all rights, obligations and corresponding duties and responsibilities subsisting and in force therein shall be respected and mandated till the finalization and accomplishment thereof.

All legal matters and connected issues will be within the jurisdiction and adjudication of the Tezpur court.
