TEZPUR COLLEGE AND EDUPUR FOUNDATION

This agreement is made on 21th Day of March, 2024 between the Tezpur College, a government-aided educational institution in Tezpur, Pin-780001 hereinafter called "College", as the first party and the Edupur Foundation, a social service Non-Governmental Organization of Tezpur, Pin-784001, as Second Party.

1. PURPOSE

The Purpose of this Memorandum of Understanding (MOU) is to establish a working arrangement between the College and Edupur to assist the development of professional skills of students by aiding career counseling, training, providing courses and assist in employment opportunities to the students. By this MOU two parties agree to cooperate for greater benefit of students by creating post education job opportunities in the corporate sectors. This MOU represents a non-binding expression of intent between the parties to work together to promote skill training and education, placement of students in suitable industry as working professionals.

2. BACKGROUND

Tezpur College

Tezpur College, established in 1965 with the untiring and selfless efforts of some of the enlightened citizens of Tezpur, has now emerged as one of the premier institutions of Higher Education in the North Bank of Assam. Late Dulal Chandra Bhattacharjee, the founder President and late Padma Prasad, the first acting Principal, along with some other zealous citizens shouldered the responsibilities of moulding the college to cater to the needs of Higher Education in the North Bank of Assam.

The College is affiliated to Gauhati university w.e.f. 01/12/1972. The College offers courses in Bachelor of Arts (B.A.), Bachelor of Science (B.Sc.) and Bachelor of Commerce (B.Com), as also Higher Secondary(Arts and Commerce) courses. Besides the regular courses the College also offers Programmes in Business Administration(BBA), Travel and Tourism Management (TTM), B. Muse and M. Muse. 3. COLLABORATIVE OBJECTIVES AND ACKNOWLEDGMENT

Both the parties agree to provide awareness training, placement & career counseling to the students of the college and other district candidates, enabling them a clearer vision and career prospective as well as provide them a platform by collaborating with companies looking for recruitment.

4. WORKING AGREEMENT

Both the parties agree to share their specific expertise regarding bridging the unemployment gap through skill training. To facilitate this collaboration, the parties agree to share student database, success stories, career counseling, placement drive, time-to-time workshops to the students.

 - A. This MOU is strictly for internal management purposes for each of the parties. It is not legally enforceable and shall not be construed to create any legal obligation on the part of either party. This MOU shall not be construed to provide a private right or cause of action for or by any person or entity.
 - B. This MOU will be in effect for a period of 3 years and can be renewed by written agreement of both parties. It can be terminated by either party at any time by providing notice in writing to the other party.

- C. This MOU in no way restricts either of the parties from participating in any activity with other public or private agencies, organizations or individuals.
- D. This MOU is neither a fiscal nor a funds obligation document. Nothing is this MOU authorizes or is intended to obligated to obligate the parties to expend, exchange, or reimburse funds, services or supplies, or transfer or receive anything of value.
- E. All agreements herein are subject to, and all be carried out in compliance with, all applicable laws, regulations and other legal requirements.
